



Publication of the Little Bollington Neighbourhood Plan (Pre-Submission Version)

The Neighbourhood Planning (General) Regulations 2012 (Regulation 14)

Little Bollington Neighbourhood Forum, as the qualifying body, has prepared a Neighbourhood Plan for the period to 2030 (the Plan) for Little Bollington with the help of the local community. The Plan sets out a vision for the future of Little Bollington and planning policies, which will be used to determine planning proposals locally. Little Bollington Neighbourhood Forum is now inviting comments on the proposals in this Pre-Submission version of the Plan, before it is submitted to Cheshire East Council for formal consideration and wider consultation.

The consultation opens for comment on Monday 3rd October 2022. The deadline for comments to be received by Little Bollington Neighbourhood Forum is 5pm on Monday 14th November 2022.
